On October 26, 2017, the kick-off meeting of the Erasmus + project "STOP! ASD HAZARDS" took place in Zaragoza (Spain). The inaugural event was held at the ESIC-Business & Marketing School facilities.

This event served, among other aspects, to present on the part of the AEGARE Coordinator, the Action Plan prepared to carry out the project, which will end in September 2019.



The project is conceived as a tool and methodology to promote training in prevention of occupational risks and occupational health of people affected by ASD (autism spectrum disorders), as well as those professionals who directly or indirectly participate in professional training and integration labor of this group (Specialized teachers in ASD, prevention of risks, responsible for training, etc.).

To fulfill the objectives of the project, training contents for the prevention of occupational risks of the ASD collective will be designed through games that allow interacting with the student and adapting to the required level, encouraging self-learning. An educational platform will also be created, which will integrate local and regional stakeholders as well as people with ASD and promote transnational knowledge exchange networks, linked to the objectives of the project in the levels of training, research and public sector.

The main impact that is expected once the project is developed is the increase of initiatives for the social-labor integration of the ASD collective, a greater awareness of the problems of this group and an improvement of the skills of people with ASD in knowledge of occupational risks in the workplace and in the care of their occupational health.

There will be international meetings, local workshops and interviews with stakeholders in order to achieve the results sought in this project; On the other hand, the following intellectual products will be developed:

1. Analysis of risks and occupational health of the ASD collective.
2. Methodological manual for the correct training of the ASD collective.
3. Training content in prevention and occupational health.
4. Manual of Good Practices for the prevention of risks and occupational health of the ASD collective.
5. Development of Collaborative Platform and Learning Games.

ASD COLLECTIVE TASKS

To carry out the activities of the project, the partners carried out a survey in their respective countries among various "stakeholders" (word that means people or entities interested or affected by the decisions of, in turn, other persons or entities).
